

Official Resolutions Adopted by the Director Generals Meeting
For the Sixth Session of the
International Forum on Crime and Criminal Law in the Global Era
(English version)

Resolution No. 1:

Modifications for the Resolutions adopted by the general conference of the Six Session of IFCCCLGE

The Director Generals Meeting applauded the text of the Resolutions with two modifications: (1) Change the “**Resolutions** of the Sixth Session of the International Forum on Crime and Criminal Law in the Global Era” to “**Declaration** of the Sixth Session of the International Forum on Crime and Criminal Law in the Global Era,” and (2) Change the phrase “*Adulterated Food and Drug Crimes intertwine with terrorism, organized crimes, corruption and other kinds of global crimes*” to “*Adulterated Food and Drug Crimes intertwine with organized crimes, corruption and other kinds of global crimes*”

Resolution No. 2:

Matter regarding to establish “United Nations Convention on Prevention and Controlling of Adulterated Food and Drug Crimes”

The *Declaration of Sixth Session of the Forum* called on all people and all nations of the world, the United nations, and to all intergovernmental and international non-governmental organizations: take actions immediately and work hard to establish an “**United Nations Convention on Prevention and Controlling of Adulterated Food and Drug Crimes**”. To this end, Director General of each State must take all effective means that can be employed with the widest publicity, if possible, so more and more people accept this concept; shall also take all effective actions to influence the government, prompting the government to the United Nations

officially to conclude " **United Nations Convention on Prevention and Controlling of Adulterated Food and Drug Crimes**". On this issue, it is laudable and learns from the Director General of Russia's statement at the Meeting on how to influence public opinion and especially on the Putin government.

Resolution #3:

Continue to Run "Sub-Forum" in good standing

Holding the Sub-Forum this year in accordance with the Resolutions of the Director Generals Meeting at the Forum and the "Official Announcement of the Sixth Session of the Forum" on trial basis was overall in good situation.

Due to time constraints, Sub-Forum was conducted by the Secretary General's temporary arrangements instead of conducting with the specific procedures founded by the Sixth Session of the Forum, and therefore, there had many shortcomings and unsatisfactory matters that must be corrected to run the Sub-Forum smoothly in the future.

The Director Generals of each State unanimously agreed that the establishment of the Sub-Forum was utmost importance and a correct decision. It can strengthen the economic cooperation and developments of the private enterprises among the member States of the Forum (including the investments and international trades); promoting the economic developments of each country and the friendship between countries. Furthermore, it can also provide financial support on academic research, international cooperation of the main Forum and fundamental solutions to solve the unstable source of funding. It leads more solid economic foundation in regards to the development of the main Forum.

Currently, the most important issue is to follow through the "The Official Announcement of the Sixth Forum" requirements: (1) assign a consultant from each signatory State as a committee member for the "Economic Cooperation and Development Committee of the International Forum on Crime and Criminal Law in the Global Era ", the said consultant is directly supervised by the Committee that attaches to the Director General Meeting. (2) Elect one (1) Director and five (5)

Deputy Director positions for the Committee to lead and direct the Economic Cooperation and Development Committee that organize and conduct Sub-Forum matters.

It is resolved that each signatory State should provide its assigned consultant's name, photo, resume and the contact methods to the Secretariat by the end of this year to ensure the work can be conducted promptly.

After receiving the name list of the consultant selected by each State, the Secretariat shall hold the "Economic Cooperation and Development Committee of the International Forum on Crime and Criminal Law in the Global Era" as soon as possible to research and arrange the future works in Beijing.

Resolution #4:

Expansion and Perfection of the organizations of the Forum signatory States

With the rapid developments of the Forum, the present organizations of the Forum signatory States cannot meet and satisfy the needs of the Forum development. This severe discrepancy must be resolved. Therefore, this session's Director Generals Meeting proposed to expand and adjust the organizations of each signatory State and hopefully would accomplish by the end of March 2015.

1) Director General: the Director Generals' absence from the Director Generals Meeting caused very negative impact on their authorities and their works, and therefore, each signatory States shall appoint two (2) Director Generals in the future: the Director General First Ranking and the Director General Second Ranking. The Director General Second Ranking shall sit for Director General First Ranking to attend the Director Generals Meeting when Director General First Ranking is unable to attend the whole or part of the meeting.

2) Consultative Committee: Resolved to change the numbers of the consultants from 3-9 people to 4-15 people of each signatory State and consists with the following four categories of elites:

- a. Theoretical and practical experts and scholars;
- b. High ranking government officials;

c. Economic elites;

d. Attorneys.

Increasing the need of attorneys is required to strength the rule of laws and also to carry out Sub-Forum works. When the Sub-Forum develops international trade and investment activities between private entrepreneurs among countries, the countries, the Forum will organize groups of international legal counsels to provide legal services and protections.

(3) The Executive Director: resolved to modify the numbers of the Executive Director of each signatory State from 3-9 to 4-15 in order to meet the urgent need of the increasing scientific research.

(4) Experts (Think Tank): Forum already stipulates the formation of a pool of experts. Representatives attended the forum each year automatically become expert member unless explicitly opposed by himself/herself. However, the Secretariat did not seriously implemented. To correct this error, the Secretariat requests Director General of each signatory State to provide a name list of its representatives that participated the past years' Forum (includes names, photos, resumes and contact information), to the Secretariat as soon as possible in order to be included into the Forum organizations. When Forum requires, for example, to draft the United Nations Convention on the Prevention and Control of Adulterated Food and Drug Crimes", experts can be selected from the pools to form a drafting committee in charge of that matter.

It also resolved that each signatory State should completed its organization reform by the end of March 2015 and send the name lists, photos, resumes, and contact information to the Secretariat to compose and edit into a book to be released to the public.

Resolution #5:

New signatory State

So far, this forum has 19 signatories: (by alphabetical order): they are Argentina, Brazil, , China, France, Germany, Hungary, , USA, Japan, Spain, Switzerland, South Africa, Mexico, Serbia, Macedonia, Lithuania, Bulgaria and Russia. To meet the

needs of the development of the forum, it is resolved to add 21 more signatory States on the basis of the original 19 States to make the Forum more representative with 40 signatory States in the next two years (2014-2015).

Scholars of Britain, Korea, India, Malaysia, Indonesia, Thailand, Egypt and Libya in the north Africa, Australia and some other countries have kept regular contacts with the Forum also have expressed their willingness or have showed their interest in this Forum. We, therefore, shall make contact with them directly. Add new signatory States is the signatory States' responsibilities and we must work together to accomplish. During the conference, Director Generals from Russia, German, Brazil, and Argentina offered their willingness to development some countries as signatory States for the Forum and we applauded their positive attitude.

The Meeting reconfirmed the new signatory States must meet two conditions: a. recognizes and signs the Declaration of the Forum; b. Organize the related institution according to meet Forum's requirements (such as Director of General, consultants, and etc.)

To speed up the progress of developing new signatory States, it is resolved: that besides being approved by the Director General Meeting as a traditional method, a new signatory State can be developed through emails soliciting the opinions of the Director Generals separately. Each Director General can approve or disapprove after reviewing the application materials. In principle, the applying country can be approved as a signatory State of the Forum if it has approved by more than two-thirds of the votes from the Director Generals.

Resolution #6:

The theme topic of the 7th session of the Forum for next year (2015)

After full discussions at the Meeting, all agreed the theme topic for the next year's Form session is "**Criminal Penalty Theories and its Practices in a Global Era**".

In the 2nd session of the Forum held in 2010, all agreed the theory and basic viewpoints of "**Theory of Human Rights Defense**" proposed by Professor Bingsong

He and further agreed to promote the “Theory of Human Rights Defense” to the public as a significant concept of the International Forum on Crime and Criminal Law in the Global Era to reform the criminal laws globally.

In the 4th session of the Forum held in 2012, the Forum deepened the researches and discussions on the “Theory of Human Rights Defense” that enriched and developed this theory. The Meeting expected Professor Bingsong He further to revise his “**Theory of Human Rights Defense**” before the opening of the 7th session next year for a keynote speech and distributes it to delegates for their reference.

Resolution #7:

Regarding the First issue of Forum magazine English version be published either in USA or UK next year (2015)

Resolved: The expenses to issue and publish the Forum magazine English edition shall be funded by the Forum itself. The Director General who in charge of the publication in each issue shall responsible for the magazine’s qualities (including the quality of articles and its translations).

Resolution #8:

Regarding Approval Hungary as new Signatory State

After the application reports made by the representatives from Hungary, it is resolved to approve Hungary as a new signatory State who met the required conditions. However, it shall deliver all the related document to the Secretariat as soon as possible.
